**Sub:** Intimation of Conversion of Warrants into Equity Shares under the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), Regulations 2015 ("SEBI Listing Regulations")

In continuation to the intimation dated October 23, 2024, w.r.t., to allotment of Warrants, in terms of Regulation 30 of the SEBI Listing Regulations, we wish to inform you that the Board of Directors of the Company in their meeting held today i.e., Thursday, March 20, 2025, inter-alia, considered and approved the allotment of equity shares on conversion of **293700** (Two Lakh Ninety Three Thousand Seven Hundred) warrants into **293700** (Two Lakh Ninety Three Thousand Seven Hundred) equity shares at an issue price of ₹63/- (Rupees Sixty Three only) (including a premium of ₹53/-) each, to persons belonging to the Non-Promoter Category, on preferential basis, upon receipt of amount aggregating to **₹13877325**/- (Rupees One Crore Thirty Eight Lakhs Seventy Seven Thousand Three Hundred Twenty Five only) (being 75% of the issue price per warrant) @ ₹47.25/- (Rupees Forty Seven and Paisa Twenty Five only) per warrant from the allottees' pursuant to the exercise of rights of conversion into equity shares in accordance with the provisions of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018.

Post this conversion of warrants/allotment of Equity Shares, **7644300** warrants remain pending for conversion and the warrant holders are entitled to get their warrants converted into Equity Shares of the Company by paying remaining 75% i.e., ₹47.25 (Rupees Forty-Seven and Paisa Twenty-Five only) per warrant within 18 months from the date of warrant allotment.

Pursuant to conversion, the Issued, Subscribed and Paid-up Equity Share Capital of the Company stands increased to ₹23,21,87,000/- consisting of 2,32,18,700 fully paid-up Equity Shares of ₹10/- each. The new equity shares so allotted shall rank pari-passu with the existing equity shares of the Company.
